- 1. All information provided along with this application will be used solely for the purpose of extending credit and assigning applicable fuel taxes to the Customer. Length of credit terms will be dependent on credit limit granted and other factors based on Company credit policy and will be disclosed at time of acceptance. If payments are not made within terms, it is understood that our right to purchase and our credit with The Jerry Brown Co., Inc. shall immediately terminate without notice or other formality. A finance charge which is computed at the periodic rate of 1 ¾% (annual percentage rate 21%) (minimum 1.00) may be assessed on any amount due, after applying payment received, which remains unpaid for 30 days or more after closing. A fee may be assessed for any returned check or draft by your bank to us. I (we) warrant that the information provided here is accurate and may be relied upon in making your credit decision. I(we) authorize our bank and suppliers to furnish you any information necessary to complete your evaluation of our credit history. As a condition of buying, Interest of 1.75% will accrue on delinquent accounts. Additionally, the undersigned agrees to pay attorney's fees if an attorney is required to collect.

Should neither the applicant nor any agent be present at the time of delivery by Company, the Company shall be authorized to send a copy of the invoice showing the date of delivery, and such delivery shall be deemed acceptable as per this agreement unless, within five (5) days thereafter, applicant shall make known to Company in writing, of any alleged error in said invoice.
